TDI EXTENDS DEADLINES FOR LIFE, ACCIDENT & HEALTH INSURANCE

The Texas Department of Insurance issued commissioner's bulletin #B-0059-08 on September 14, 2008. The bulletin includes the TDI opinion that all health insurers and health maintenance organizations (HMO) should extend any claim filing deadlines for providers, insureds, certificate holders, or enrollees. TDI also opined that health insurers and HMOs should waive contractual restrictions requiring preauthorizations, referrals, notification of hospital admissions, and medical necessity reviews through the duration of the Governor's disaster proclamation. The extension is to last for the duration of Governor Perry's disaster declaration, which is open-ended at this time. TDI ISSUES REMINDER OF PROMPT PAYEMENT PROVISIONS

In commissioner's bulletin #B-0059-08 on September 14, 2008, the Texas Department of Insurance reminded all insurance companies and HMOs generally of the prompt payment provisions of the Texas Insurance Code and the Texas Administrative Code relating to catastrophic events. TDI believes these codes allow payers that experience a catastrophic even to toll applicable prompt payment deadlines upon communicating to the TDI the occurrence and circumstances of the event. HHSC SUSPENDS SOME MEDICAID REQUIEMENTS

In response to Hurricane Ike, the Texas Health and Human Services Commission (HHSC) suspended several Medicaid requirements. Some of these suspensions include:

• Primary care referral for Medicaid patients in the PCCM program who live in a hurricane evacuation area.

- Prior authorization requirements for Medicaid patients in the PCCM program who live in a hurricane evacuation area.
- Prior authorization requirements for Medicaid patients in the fee-for-service program who live in a hurricane evacuation area.
